Subject: - Permission to Establish a New School under Rule-29 of Haryana School Education Rules-2003,

Reference your application in form 1 under Rule-29 vide No. 734 dated 211-5-06 for permission to establish a New School.

Your proposal to establish a New School has been considered and after careful consideration you are hereby allowed to establish a New School under the provisions of Rule-29 (3) read with Rule-3 of Haryana School Education Rules-2003 subject to the condition that you will fulfill the following requirements of the Rules for permanent Recognition:

1. The Proposed School shall have the required infrastructure regarding land and Building i.e. number & size of class rooms (24'x18'x10' with veranda 10' wide) and other rooms for Head of Institutions/Office, Library, Lab, Laboratory, stairs, ramp and toilets etc. as per Rule-30.

2. The Management of the School shall apply for permanent recognition by 30<sup>th</sup> Sep. for the ensuing Academic Session as per rule-31 (form-II with necessary instructions attached).

 The management is also required to get the Scheme of Management approved from the Appropriate Authority under rule-32 before application for seeking recognition. (Form attached)

 No admission beyond Class-III shall be made by any school before the sanction of its recognition or in its anticipation.

This is only a formal permission to establish a New School does not enable your school to get recognition automatically for which physical verification of infrastructure and records in this respect shall be made by District inspection Committee headed by Additional Deputy Commissioner concerned.
